Insured risk shall mean a fact or event defined in the insurance contract as a possible cause of occurrence of the insured event, especially an obligation on the part of the insured to compensate for damage to goods in transit, caused to another person, occurring in the course of inland road transport performed in the territory of another country (cabotage) and damage arising from a failure to meet the delivery time under § 7a, **Güterkraftverkehrsgesetz (GüKG)**, which the insured is obliged to compensate under **the fourth part of the fourth book Handelsgesetzbuch**. Terms and conditions, and the extent of the insurance are defined by the insurance contract and General Insurance Terms and Conditions for Road Carrier's and Forwarder's Third Party Liability Insurance VPPDZ-P-01/2014.
